When suppliers start to deliver products to Display Group (including,, KTC, SKC, and Corporate Display Group of Kyocera Corporation), Display Group requests suppliers to refer to and comply with both the Guideline and the Annex for products to deliver.

- *6: RoHS substances (Resin parts are 10 substances as of August 2023) are bare minimum requirement.
- *7: The analysis shall be done for each homogeneous material.
- *8: The outline of No.4 analytical data and No.5 SDS is provided in the Guideline.

${ m II}\,$. AT THE TIME OF SUBMISSION

In each of the following events, please submit the relevant data prior to shipment of the applicable delivery item.

- (1) When new materials or parts adopted
- (2) In case of 4M changes or specification changes after mass production started, (including their sub suppliers).
- (3) Upon request for information by Display Group

If necessary, we may request to provide information on

- [1] unchecked items in the past,
- [2] products delivered before the change of regulations such as the RoHS directive, and
- [3] prototypes.
- (4) At the time of revision of the controlled substance by each directive such as RoHS directive,

REACH regulation, etc

When the supplier recognizes the use or substances of the applicable chemical substances after verification of any possible chemicals to be newly controlled or reported, based on the necessary precaution duty of common trade practice.

The state change of chemical compounds, degradation, etc., based on the necessary precaution duty of common trade practice.

- (5) When there is a change in the content of chemical substances constituting the product due to new knowledge, etc.
 - * Suppliers are responsible for chemical changes in ingredients and When the existence of a chemical substance that should be managed and reported due to a change in the state of a chemical compound, deterioration, etc. is recognized.

Example) When it is found that a prohibited substance exists as an unintended by-product. (Please contact us even if it is less than the BAT control value.). Also, "From the purchaser If it is known that the product is contained in the purchased raw materials, the N.D.

Even if it is less than the analytical lower limit, please let us know the analytical data and the approximate value together.)

(6) When information on contained chemical substances falling under (4) and (5) above is obtained from the purchaser.

III. SUBMISSION METHODS

- (1) To be submitted in the specified file format in each forms.
- (2) When Display group requests for information, please submit the specified data within 14 days from the request date unless otherwise noted.

When in any difficulty in submission in time, the planned submission date shall be presented with in 7 days from the request date.

(3) When all of the requested data can not be presented, please submit the finished data first.
